#### **Late Fees**

A charge of \$25 will be assessed for tuition payments received more than 5 business days after the 1st of the month. If tuition is not paid in full by May 15<sup>a</sup> of the current school year a \$100 fee shall be charged to your account. If your account is delinquent more than 30 days, your child may be required to stay out of school until the account is made current.

#### **Enrollment After the Start of the School Year**

Students who enroll and begin attending after the first day of the school year will receive a discount from the total amount of tuition equal to the proration of the tuition rate for each school day prior to enrollment.

#### **Student Withdrawal and Refund Policy**

Two weeks written notice is required for withdrawal of children from the school. *The registration fee, first tuition installment and materials fee are all non-refundable*. If a child is withdrawn from school after April 1<sup>st</sup> of the current school year, tuition is not refundable and all unpaid tuition is due.

#### **Termination**

The school reserves the right to terminate any child whom, in the opinion of the Directress, is unable to adjust to the Montessori program. Should it be necessary to employ an attorney to enforce this agreement, the parent agrees to pay reasonable attorney's fees. In addition, the school reserves the right to terminate this agreement if the signing party were to cause any detriment to the school.

#### **Parent Handbook**

The current Parent Handbook supplements this agreement and is incorporated herein by reference. The handbook is subject to change in August of each year, and the changes shall become part of this agreement.
